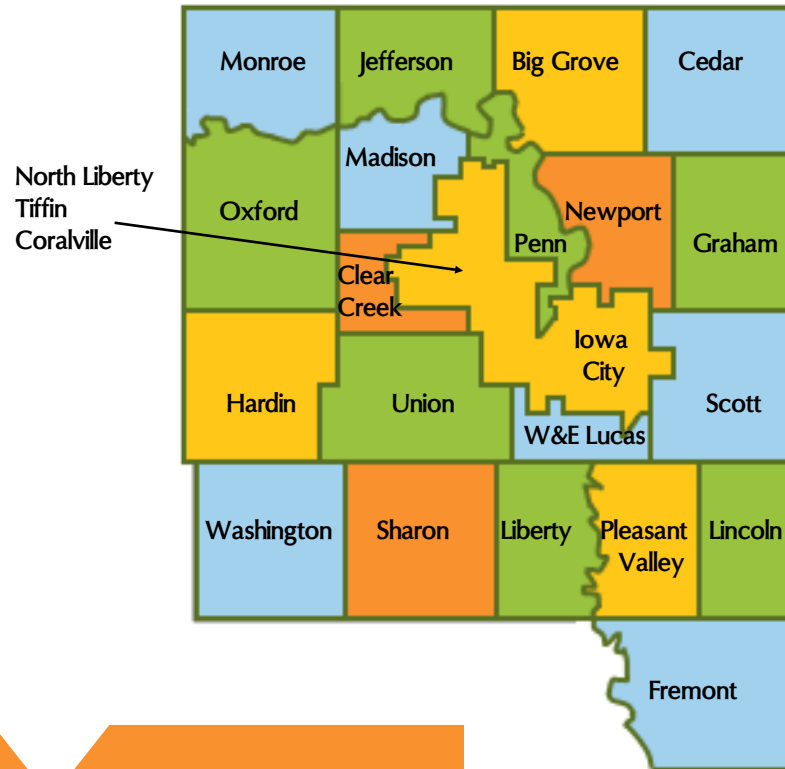
Johnson County mission

- Johnson County is named after Colonel Richard Mentor Johnson. Colonel Johnson was in the War of 1812, a Senator from Michigan and the Vice President of the United States during the Van Buren administration.
- The County was established in 1837 and the County seat is located in Iowa City.

- The County's population in 2016 was 144,250.
- Eleven cities are located within the County.
- Johnson County has more than 900 miles of paved, gravel and dirt roads.
- The County's land area covers 614 square miles.
