Construction Projects: (\$10M+ construction)

<u>I-33-1 Bridge Replacement (Utah Avenue over branch of Rapid Creek)</u>: Done. Replaced bridge with a Reinforced Concrete Box culvert.

I-9-1 Bridge Replacement (Putnam Street over East Fork Rapid Creek): Done.

E-20-2 Bridge Replacement (Black Hawk Avenue over branch of Clear Creek): Done.

Melrose Ave / F46 / IWV Road (Hebl to Hwy 218): Construction in progress.

Herbert Hoover Hwy / F44 Ph 3 (0.9 mi east of Wapsi Avenue to 0.2 mi west of Johnson Cedar Road): Let in August. Contractor opting to start in 2022.

Secondary Roads -Green Initiatives/Sustainability



Maintenance:

- Continue to Recycle dumped Appliances left in the ditch.
- Continue to purchase Tier 4 compliance clean diesel engines.
- Using Recycled Asphalt on various projects throughout JC.
- Vehicle oils/filters and used tires are recycled.
- Old Signs, Steel Parts & equipment are recycled.

Green/Climate Adaptation Initiatives:

The upcoming Ely Road project incorporates raising the road profile over a foot above the maximum 2008 flood level to provide a continuous paved artery between Cedar Rapids and Iowa City. Together with the flood mitigation design incorporated on Hwy 965 last year, we are actively addressing climate change extremes by providing redundancy in our transportation network. Johnson County is leading the way in this critical transportation corridor.





Secondary Roads - Other



Outreach Efforts: The Department continues, as part of the Boards Strategic Priority III, multiple outreach efforts to increase transparency and keep the public informed about our operations and construction projects via: Dynamic Message Boards, QR Code Signs, County Website, Newsletter, Media, Twitter, Press Releases, multiple meetings with various Cities in Johnson County and various professional organizations. Staff will continue reach out to Local Schools to promote County Engineering and Maintenance Activities for students looking into alternative employment opportunities.

<u>Utility Permits</u>: To date we have received 123 permits. This will likely be an all time record year and is likely to continue as storm hardening projects from the Derecho and Federal Funding for infrastructure come in. Approximate average staff time/permit: 8 hours.

<u>Oversize/Overweight Permits</u>: To date we have reviewed 116 permits, approximate average staff time/permit: 2 hours.

<u>Right of Way Permits:</u> To date we have reviewed 58 permits, approximate average staff time/permit: 8 - 10 hours.
