RESOLUTION CB# 6-09/20/22-75

RESOLUTION AUTHORIZING AMENDMENT TO RANGER I AND RANGER II JOB DESCRIPTIONS AND AUTHORIZING RESIDENCY GUIDELINES FOR KENT PARK

WHEREAS, Iowa Code 350.4 empowers the Johnson County Conservation Board (JCCB) to "have custody control, and management of all real property . . . acquired for parks . . . and other county conservation purposes," within Johnson County.

WHEREAS, the JCCB adopted a Housing Policy through resolution #CB/9-3/29/01 setting for the policy requiring Park Rangers to reside on the area to which they are assigned; and

WHEREAS the JCCB has made a number of land acquisitions since 2001 greatly increasing the number of properties under management of the JCCB; and

WHEREAS the JCCB acknowledges that the Park Rangers are now required to respond to a variety of issues at multiple conservation properties throughout Johnson County, including but not limited to Kent Park; and

WHEREAS the needs identified in the Housing Policy as identified in Resolution #CB/9 3/20/01, continue to necessitate the residency of one ranger at Kent Park, however the current needs for ranger coverage do not necessitate a residency requirement for both park ranger positions; and

WHEREAS the current demands for ranger coverage require the supervisory ranger position (Ranger II) to reside within Johnson County or within twenty-five miles of Kent Park in order to be available for supervisory duties and to respond to emergency situations at various JCCB properties in a timely manner; and

WHEREAS the JCCB recognizes the need to have site specific residency guidelines for JCCB properties that necessitate on-site residency and that such guidelines

should reflect the nature of the property, the type of services offered on site and the nature of the residence provided; and

NOW, THEREFORE, BE IT RESOLVED that the JCCB authorizes the Director to amend the job descriptions for the Park Ranger I and Park Ranger II positions to require residency at Kent Park for the Park Ranger I position and to remove the Kent Park residency requirement for the Park Ranger II position, and to add a proximity mileage requirement to the Ranger II position, and

BE IT FURTHER RESOLVED that the JCCB approves and adopts the Johnson County Conservation Board Residency Guidelines for Kent Park (as attached) as the basis for a residency agreement at Kent Park as required in the updated Ranger I job position.

BE IT FURTHER RESOLVED that JCCB authorizes the Director to make minor modifications and updates to the Residency Guidelines at Kent Park as necessary for consistency with other JCCB policies and to accurately reflect the amenities provided at the residence at Kent Park.

On motion by <u>Gene Zdrazil</u> seconded by <u>Connie Mutcl</u> passed and approved the <u>20</u>th day of <u>Sept.</u>, 2022.
