RESOLUTION CB# 6 - 10/18/22 - 75

RESOLUTION RECOMMENDING JOHNSON COUNTY BOARD OF SUPERVISORS GRANT A PERMANENT WATER MAIN EASEMENT TO THE CITY OF SOLON

WHEREAS, Iowa Code 350.4 empowers the Johnson County Conservation Board (herein, "JCCB") to "have custody control, and management of all real property . . . acquired for parks . . . and other county conservation purposes," within Johnson County; and

WHEREAS, the JCCB manages and maintains the portion of the Hoover Trail to the west of the City of Solon (herein, the "City") and Johnson County (herein, the "County") owns the portion of the trail right-of-way immediately to the south of the Hoover Trail for which the City is seeking a Permanent Water Main Easement; and

WHEREAS, the City contacted the JCCB to request the County grant Solon a Permanent Water Main Easement across and under designated property owned by Johnson County immediately adjacent to the south of the Hoover Trail, (herein, the "Property"), as shown on shown on Attachment 1, (Draft Acquisition Easement Agreement, Exhibit A); and

WHEREAS, the City is requesting the Permanent Water Main Easement in order to facilitate the construction of a water main from the City's property, under and across the Property, then under and across the existing paved portion of the Hoover Trail and proceeding northwesterly to the Trail Ridge Estates subdivision as shown on Attachment 1, Exhibit B; and

WHEREAS, in consideration for granting the Permanent Water Main Easement, Solon has agreed to accept responsibility and liability for the Water Main project and any

damage that might occur to the Property or the existing portion of Hoover Trail that runs adjacent to the water main as set forth in the Easement Acquisition Agreement including Exhibits A, B and C; and

WHEREFORE, the draft language of the Permanent Easement Agreement is set forth in Attachment 1, Exhibit C; and

WHEREFORE, Iowa Code Section 331.361 (2) (2022) requires Johnson County, in disposing of a real interest in property to set forth its proposed plan in a resolution, to publish notice of the time and place of a public hearing on the proposed plan and, after the public hearing make a final determination on the proposed plan; and

NOW, THEREFORE, BE IT RESOLVED having reviewed the plans and specifications for the proposed Water Main project, and its potential impact on the existing on Hoover Trail, the JCCB recommends the Board of Supervisor's set a public hearing to consider granting a Permanent Water Main Easement to the City of Solon based on the consideration as described in the Easement Acquisition Agreement including Exhibits A, B and C as set forth in Attachment 1.
