## LOCAL UPDATES:

- General
  - Expense Report: Our February 2023 expense report is in your board packet.
  - Legislative Forum: We hosted a successful Legislative Forum on Friday March 10- 8:30-9:30am. We had 5 legislators in attendance.
- Programs
  - School Ready Scholarships: I was able to approve 1 additional Scholarship Application this month.
  - **Car Seats and Safe Sleep:** We have 3 safe sleep events scheduled in April (one is in North Liberty). We have also been doing car seat checks one afternoon or morning per week (these appointments have been filling quickly).

• Committees

  - Child Care Wage Supplement: This program has rolled out and in the first round applications from 11 programs were received.
  - Week of the Young Child: I have been part of the planning committee. A Mindful Movement Training will be held April 4 at the Iowa Children's Museum. I will provide books to be distributed to child care providers who attend. We will discuss funding the training when we look at the budget.
  - Kites for Kids: Events will be held in April. I will try to attend to distribute books

#### THE THIRD AMENDMENT to the CONTRACT entered by the parties on July 1, 2022

Pursuant to Paragraph 11.11 Amendments of the Contract entered by United Action for Youth and Johnson County Empowerment/ECIA Board for the Young Parent Program entered by the parties originally on 07/01/2022 the Contract is amended effective March 23, 2023 as follows:

- **5.2 Required Performance Measures.** The Service Provider shall document and report all state required data including but not limited to:
  - **5.2.1** The # of children served (by age). The # of families served in the home visitation program. **Target is 60 children.**
  - **5.2.2** The # of families served in the home visitation program. **Target is 40 ECI eligible families.**
  - **5.2.3** The # of participants served in group-based programming. **Target is 15.**
  - **5.2.4** The # of home visits completed. **Target is 615.**
  - **5.2.5** The # of group parent education meetings offered. **Target is 25.**
- 6.3 Pricing. The Service Provider will be paid for the services described in the Scope of Services section a fee not to exceed \$100,000 for the Contract period (07/01/2022-06/30/2023). This shall be the total compensation paid to the Service Provider.

All other provisions of the Contract will remain in effect
