Whereas, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

Whereas, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR’s decision regarding a specific application; and

Whereas, by adopting a construction evaluation resolution the board of supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the board of supervisors between February 1, 2023 and January 31, 2024 and submit an adopted recommendation regarding that application to the DNR; and

Whereas, the board of supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code section 459.305, but the board’s recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix.

Now, therefore, be it resolved by the Board of Supervisors of Johnson County that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code **section 459.304(3).**

WHEREAS, Chapter 28E of the Iowa Code (2021) enables two or more local governments to enter into agreements to cooperate for their mutual advantage; and

WHEREAS, Iowa Code Section 354.9 gives the City and the County the authority to establish, by agreement, the standards and conditions applied by a city or county for review and approval of a county subdivision, and other development applications to which such an agreement may be addressed; and

WHEREAS, pursuant to these powers, the City and County did enter into a 28E Agreement in September 2008 pertaining to the City / County Fringe Area; and

WHEREAS, it is in the interest of the County and the City to update the applicable policies for orderly growth and development within the City / County Fringe Area and, accordingly, the planning and development staff of both the County and the City have developed a draft new agreement to supersede and replace the September 2008 fringe area agreement; and

WHEREAS, the Solon City Council, following a public meeting on December 7, 2022, has reviewed this draft new fringe area policy agreement and approved said agreement by resolution; and

WHEREAS, the Johnson County Planning and Zoning Commission, following a public meeting on January 9, 2023, has reviewed this draft new fringe area policy agreement, filed its report, and recommended that said agreement be approved; and

WHEREAS, having received the report and recommendation of the Johnson County Planning and Zoning Commission, conducted a public hearing on February 9, 2023, considered the information and objections presented at said hearing, if any, and otherwise informed itself of the particulars of the proposed Fringe Area Policy Agreement;

AUTHORIZING WEIGHT EMBARGOES ON SECONDARY ROADS

Whereas, the recent weather conditions have caused soft subgrade and surface conditions to develop on some Secondary Roads; and

FUND TO THE DEBT SERVICE FUND IN THE FISCAL YEAR 2023 BUDGET

Whereas, budgeted revenues in the Debt Service Fund are intended for the payment of County debt principal and interest obligations; and

Whereas, an insufficient amount of Fiscal Year 2023 property tax revenues in the Debt Service Fund have been collected to date and interest costs exceeded what was estimated and budgeted for in the current fiscal year, and scheduled debt payments are due on June 1, 2023. This creates the likely event of a shortage of cash during the current fiscal year; and

Whereas, there is sufficient unassigned cash in the General Basic Fund to satisfy the anticipated shortfall of cash and tax revenues in the Debt Service Fund to satisfy the current fiscal year debt obligations; and

Therefore be it resolved that up to \$500,000 be transferred from the General Basic Fund to the Debt Service Fund during Fiscal Year 2023, and authorize the Johnson County Auditor to transfer up to \$500,000 to the Debt Service Fund from the General Basic Fund during Fiscal Year 2023 as tax revenues are available and adequate cash flows are appropriate.

RESOLUTION OF SUPPORT FOR BROADBAND INTERVENTION ZONE STATUS FOR CERTAIN COMMUNITIES IN JOHNSON COUNTY, IOWA

WHEREAS the term “Broadband” is minimally defined as “the transmission of wide bandwidth data to a particular address location at 100 megabits per second download and 20 megabits per second upload service or faster”; and

WHEREAS Johnson County has a goal for each premise in the county to have access to 100 megabits per second upload and download service; and

WHEREAS Johnson County, Iowa (“Johnson County”) has identified addressing Broadband deficiencies as a matter of public interest as evidenced by commissioning and receiving a countywide Broadband Study (“JC Broadband Study”) to determine current Broadband access gaps, areas where providers are likely to extend services, and where gaps will persist due to barriers limiting future Broadband investments; and

WHEREAS the JC Broadband Study contained analysis of a Market Assessment of provider-reported Broadband services and speeds, responses by key stakeholders at meetings, FCC mapping data, State of Iowa Broadband grant eligibility maps, and provider input to verify the existence of Underserved Locations and Unserved Locations (“Locations”), as defined by the State of Iowa Office of the Chief Information Officer (“OCIO”) in its Invitation to Qualify for Broadband Intervention Zoned application (“ITQ Application”);

WHEREAS the ITQ Application defines “Communities” as “a gathering of individuals representing households, schools, and/or businesses in a particular area in the State of Iowa with a shared interest in eliminating Unserved or Underserved Locations within a Geographic Area of Concern”, with increased priority given to Communities demonstrating support from its leaders; and

WHEREAS Johnson County has identified three separate Communities of Underserved and Unserved Locations within Johnson County that are resulting in economic, education, and health access disparities described in the JC Broadband Study for consideration by the OCIO for designation as a Geographic Area of Concern; and

WHEREAS these Communities have unique degrees of historically disadvantaged populations for which special emphasis should be afforded under relevant federal programs; and

WHEREAS these Communities are served by or have locations of Johnson County schools, hospitals, and correctional institutions.

THEREFORE BE IT RESOLVED by the Johnson County Board of Supervisors (“Board”) that:

1. The Board supports submitting Invitation to Qualify applications to qualify the following Communities to each be designated as a Geographic Area of Concern by the State of Iowa OCIO, as a matter of public interest:
 - a. SW Kansas Avenue Community
 - b. Rural Hills and Lone Tree Areas
 - c. Rural Area Between Iowa City and West Branch; and
2. Conclusions detailed in the JC Broadband Study prescribe that Broadband-related impediments exist within these Communities to directly engage in work, education, and health care that resulted from or were made apparent or exacerbated by the COVID-19 public health emergency due to lack of broadband access, as evidenced by provider-reported service and speed availability at their Location, and also in Location maps provided by the OCIO; and
3. The JC Broadband Study reports that the lack of Broadband investments in Johnson County to serve these Communities is primarily due to lack of adequate population density per square mile and challenging topography, which together increase the cost per subscriber to construct and operate Broadband service beyond any subscription revenue that could be collected; and
4. These Communities’ members’ engagement in employment, search for employment, and/or development of the requisite skills and knowledge to become employed are impeded by lack of Broadband investments in these areas of Johnson County, as identified by key stakeholders and reported in the JC Broadband Study; and
5. Broadband investments in these Communities, once designated as Geographic Areas of Concern, will help facilitate educational activities at Underserved and Unserved Locations as part of a person’s participation in school, academic programs, or social-emotional development programs for students or youths, improve internship opportunities, increase professional development program participation, and provide other educational experiences not otherwise afforded to the people at these Locations; and
6. Broadband investments in these Communities, once designated as a Geographic Area of Concern, will help facilitate health monitoring services to monitor an individual’s health, including with respect to either physical or behavioral health; and
7. The Board, as being direct representatives of those at Underserved and Unserved Locations within Johnson County, hereby supports these Johnson County

Communities, as geographically defined in ITQ Applications to be filed, for future Broadband investment as proposed Geographic Areas of Concern; and

8. Johnson County endeavors in a non-binding, streamlined manner and in good faith to provide or coordinate efforts to directly support construction of Broadband infrastructure projects that accelerate Broadband investment, and which may include but are not limited to:
 - a. Use of public Rights of Way (“ROW”) where applicable.
 - b. Streamlined ROW permitting for Broadband investments serving groups of Locations.
 - c. Increased County staff time and support to coordinate with providers on grant and other funding opportunities.
 - d. Fostering private economic development investments and partnerships, including in-kind use of multiple Community members’ facilities (such as putting communication infrastructure on private property).

RESOLUTION NO. 04-06-23-02

Authorizing Johnson County, Iowa to Enter into Settlement Agreements with Teva, Allergan, CVS, Walgreens, and Walmart and Future Settlement Administration

WHEREAS, in 2018, the County Board of Supervisors authorized Johnson County (the “County”) to enter into an engagement agreement with Crueger Dickinson LLC, Simmons Hanly Conroy LLC and von Briesen & Roper, s.c. (the “Law Firms”) to pursue litigation against certain manufacturers, distributors, and retailers of opioid pharmaceuticals (the “Opioid Defendants”) in an effort to hold the Opioid Defendants financially responsible for the impact of the Opioid Epidemic on the County and resources necessary to combat the opioid epidemic;

WHEREAS, on behalf of the County, the Law Firms filed a lawsuit against the Opioid Defendants in 2018 and have been litigating against the Opioid Defendants since that time;

WHEREAS, negotiations to settle claims against several of the Opioid Defendants, specifically Teva, Allergan, CVS, Walgreens, and Walmart (the “Settling Defendants”) have been ongoing for several years;

WHEREAS, negotiations with the Settling Defendants have resulted in proposed nationwide settlements of state and local government claims involved in the Litigation;

WHEREAS, copies of the proposed terms of those proposed nationwide settlements have been set forth in the Settlement Agreements (collectively “Settlement Agreements”);

WHEREAS, copies of the Settlement Agreements as well as the deadlines for submitting the Participation Agreements to the Settlement Agreements have been made available to the County prior to the execution of this Resolution;

WHEREAS, the Settlement Agreements provide, among other things, for the payment of a certain sum to settling government entities in Iowa including to the State of Iowa and Participating Subdivisions, as that term is defined in the Settlement Agreements, upon occurrence of certain events as defined in the Settlement Agreements (“Iowa Opioid Funds”);

WHEREAS, the Iowa Opioid Funds will be allocated in accordance with the Iowa Opioid Allocation Memorandum of Understanding (“Allocation MOU”), previously entered into by Johnson County on December 17, 2021;

WHEREAS, the Allocation MOU divides Iowa Opioid Funds as follows: (i) 50% to the State (“the Iowa Abatement Share”) and (ii) 50% to Participating Local Governments (“LG Share”), less fees and costs allocated to the Iowa Backstop Fund as set forth in Section D of the Allocation MOU (“LG Abatement Share”).

WHEREAS, the LG Abatement Share shall be distributed in direct payments to the Counties that are Participating Local Governments according to the allocation model developed in

connection with the proposed negotiating class in the National Prescription Opiate Litigation (MDL No. 2804) in the amounts set forth on Exhibit 2 to the Allocation MOU (“Direct Distribution Percentage”). The Direct Distribution Percentage will be multiplied by the total LG Abatement Share to arrive at the total allocation to the County as a Participating Local Government (the “Direct Distribution Amount”).

WHEREAS, 100% of the Iowa Abatement Share and the LG Abatement Share, regardless of allocation, shall be utilized only for Opioid Related Expenditures incurred after the Effective Date of the MOU. The list of approved Opioid Related Expenditures are set forth in Exhibit 1 to the MOU.

WHEREAS at least 75% of the Iowa Abatement Share and 75% of the LG Abatement Share shall be utilized for only the “Core Strategies” listed in Schedule A of Exhibit 1 to the MOU.

WHEREAS, the Settlement Agreements provide for the payment of attorney’s fees and legal expenses owed by States and Participating Local Governments to outside counsel retained for Opioid Litigation. To effectuate this, the Court in the MDL Litigation has established a fund to compensate attorneys representing plaintiffs in the Litigation (the “National Attorney Fee Fund”).

WHEREAS, the Law Firms intend to make application to the National Attorney Fee Fund. However, because there is still uncertainty regarding what counsel for litigating local governments will recover as compensation for the large volume of work done and the large out of pocket expense of the Litigation, and whereas the Parties to the Allocation MOU desire to fairly compensate outside counsel for the work done on behalf of the Participating Local Governments in Iowa, the Allocation MOU provides that a fund be created from approximately 15% of the LG Share attributable to the Litigating Local Governments (“Iowa Backstop Fund”).

WHEREAS, the Iowa Backstop Fund is meant to compensate outside counsel for participating local governments only for amounts not recovered at the National Fee Fund attributable to their Iowa clients;

WHEREAS, to be eligible for the Iowa Backstop Fund, the Law Firms must first seek payment from the National Attorneys’ Fees Fund and may not recover amounts attributable to Counsel’s representation of the County received at the National Attorneys’ Fees Fund from the Iowa Backstop Fund;

WHEREAS, the County, by prior Resolution, agreed to the creation of the Iowa Backstop Fund in the amount of 15% of the LG Share attributable to the Litigating Local Governments in order to fund a state-level “backstop” for payment of the fees, costs, and disbursements of the Law Firms;

WHEREAS, in no event shall the total of the amounts received by the Law Firms at the National Attorney’s Fees Fund related to the County and the amount received at the Iowa Backstop Fund exceed the amount the Law Firms would have been entitled to pursuant their fee contract with the County;

WHEREAS, the County, by prior Resolution, established an account for the receipt of the LG Abatement Share consistent with the terms of this Resolution (“the LG Abatement Fund”);

WHEREAS, the County’s LG Abatement Fund is separate from the County’s general fund, is not commingled with any other County funds, and is dedicated to funding opioid abatement measures as provided in the Settlement Agreements and the Allocation MOU;

WHEREAS, the County must comply annually with the reporting requirements in the Allocation MOU;

WHEREAS, if the County elects to become a Participating Subdivision in the Settlement Agreements it will receive the benefits associated with the Settlement Agreement and the Allocation MOU, provided the County (a) approves the Settlement Agreements; and (b) executes the Participation Agreements stating the County’s intention to be bound by the Settlement Agreements.

WHEREAS, the intent of this Resolution is to authorize the County to enter into the Settlement Agreements by executing the Participation Agreements;

NOW, THEREFORE, BE IT RESOLVED: the County Board of Supervisors hereby approves and authorizes Lisa Green Douglass, the Chairperson of the Johnson County Board of Supervisors, to settle and release the County’s claims against the Settling Defendants in exchange for the consideration set forth in the Settlement Agreements, Allocation MOU, and all exhibits thereto, including taking the following measures:

The execution and delivery of the Participation Agreements (a/k/a Subdivision Participation Form) to the Teva, Allergan, CVS, Walgreens, and Walmart Settlement Agreements and any and all documents ancillary thereto, by electronic means or otherwise, along with the execution and delivery of any and all further and other documents necessary to effectuate the foregoing and the terms of this Resolution.

BE IT FURTHER RESOLVED: the County Board of Supervisors hereby authorizes the duly elected and then-serving Chairperson of the Johnson County Board of Supervisors, to consider and approve settlement and release of County claims against other Opioid Defendants upon such terms and consideration as may be set forth in future settlement agreements recommended from time to time by the Law Firms, and are in the best interest of Johnson County, upon the advice and consent of the Johnson County Attorney, and execute and deliver participation agreements or equivalent forms in connection therewith and any and all documents ancillary thereto, by electronic means or otherwise.

BE IT FURTHER RESOLVED: the County shall deposit LG Abatement Share proceeds in its account titled “LG Abatement Fund” as it receives such funds pursuant to the Settlement Agreements.

BE IT FURTHER RESOLVED: all actions heretofore taken by the Board of Supervisors and other appropriate public officers and agents of the County with respect to the matters contemplated under this Resolution are hereby ratified, confirmed and approved.

WHEREAS, Sections 331.402, 331.441 and 331.443 of the Code of Iowa authorize counties to enter into loan agreements and borrow money for the purposes of acquiring equipment and making improvements to county buildings; providing insurance or funding self-insurance programs or local government risk pools; financing the provision of vehicles for a regional transit district; and funding programs to assist in providing affordable housing (the “Essential County Purposes”); and

WHEREAS, the Board of Supervisors (the “Board”) of Johnson County, Iowa (the “County”), has proposed to enter into a loan agreement (the “Essential County Purposes Loan Agreement”) in a principal amount not to exceed \$13,110,400, pursuant to the provisions of Sections 331.402, 331.441 and 331.443 of the Code of Iowa, for the purpose of paying the cost, to that extent, of funding various county insurance programs, financing the provision of vehicles for a regional transit district, and funding a grant to the Housing Trust of Johnson County, and has published notice of the proposed action and has held a hearing thereon on April 19, 2023; and

Whereas, the U.S. Department of the Treasury (hereafter “Treasury”) allocated federal funding through the American Rescue Plan Act (hereafter “ARPA”) to Johnson County to be used for certain enumerated purposes; and

Whereas, on November 18, 2021, the Johnson County Board of Supervisors (the “Board”) approved the use of ARPA funding for supporting local food initiatives in Johnson County to increase food security and access to healthy, local options; and

Whereas, by Resolution No. 08-11-22-03 adopted on August, 11, 2022, the Board approved the establishment of the Community Food and Farm Grant Program to provide funding not to exceed \$150,000 to eligible and selected community-based food and farm businesses, nonprofits, and individuals (i) who produce, process, or distribute food for consumption in Johnson County, Iowa or who enable the carrying out of such activities, (ii) where such activities impact residents of Johnson County, Iowa, including food products grown or raised in the Johnson County foodshed, and (iii) where the grant recipient (whether a natural person or entity) realizes less than \$1,000,000 in gross income or revenue annually, whether through sales, grants, and/or donations (the “CFFG Program”); and

Whereas, the Board reaffirms the bases and rationale set forth in Resolution No. 08-11-22-03 for the establishment and funding of the CFFG Program; and

Whereas, the CFFG Program received applications from 126 eligible persons and entities in the first grantmaking round in Fall, 2022, representing a total aggregate demand of \$2,794,000 for such assistance; and

Whereas, Johnson County awarded assistance totaling \$100,000 to nine grant recipients after a review and recommendation process facilitated by the Johnson County Food Policy Council and Johnson County Local Foods Staff, and ultimate approval from the Board; and

Whereas, in a work session on January 25, 2023, the Board discussed increasing the amount of funding appropriated from Department 35 to the CFFG Program to respond to the demonstrated high need for assistance to small food and farm businesses and food insecure households; now therefore be it
