DIVISION UPDATES

Community Health:

- The Disease Prevention Specialists are finishing up school immunization audits where 20,000 some records are reviewed. The student epi team, based on the hourly volunteer rate, has provided over \$10,000.00 worth of activity in support of this project. Next, the student team will be trained on outbreak investigations and will eventually have their skills tested in hand to hand combat. Just kidding, it'll be a tabletop exercise.
- The HealthyJoCo team has compiled Issue Profiles based on the data triangulation staff and community participated along with primary and secondary data. You can view the issues here: <https://arcg.is/14vLyP1>
 - The next steps will be to prioritize the issues and take feedback from the community. The team compiled and developed the issue profiles within the last two weeks!
- Susan Vileta has taken a student team to bars and restaurants to collect qualitative data from key informant and focus group interviews on perceptions with regard to vaping and enforcement.
 - Coralville Parks and Recreation will also be approaching their final reading of their upcoming Tobacco Free and Nicotine Free Parks policy. This will be the last metro city in Johnson County to have a policy in place. More and more square mileage of Johnson County gets healthier every year!
- Nate Savage won the gold at the Johnson County Madden Football Tournament bringing glory to the department. Bragging rights continue throughout the year until the next tournament. Nate also has been assisting the Service Area's Stop The Bleed Project to identify current and new trainers.
 - **Did You Know? Stop The Bleed tourniquets are located in each of Johnson County's AEDs?! While they are not marked as such, they are in there in case of emergency!**
- Giselle, Karrey, and Kristy have been on location across Johnson County's many worksites to jab employees for flu and COVID-19. Remember, everyone is due for an updated COVID-19 vaccine now. If you are an employee that is on county insurance and your dependent who is also on county insurance, so long as you both have county insurance, you're able to be vaccinated as the qualifying criteria is to have county insurance.
- Ari led the first Building Health Equity series post the all department training. The group discussed the past 400 years of -ism in the U.S. Great job, Ari!
