RESOLUTION AWARDING CONTRACT FOR PHASE 1 OF THE KENT PARK CAMPGROUND SHOWERHOUSE PROJECT

WHEREAS, a public hearing was conducted by the Johnson County Conservation Board ("JCCB") on the 25th of January, 2023 at 5:30 p.m., concerning the proposed plans, specifications and form of contract for, and the estimated total cost of construction related to the Kent Park Campground Showerhouse Site and Utility Improvements, aka Kent Park Campground Phase 1 - Site Improvements, located at Kent Park, 2048 Hwy 6 North West, Oxford, Iowa (the "Project") and, thereafter, said plans, specifications and form of contract for, and the estimated total cost of construction related to the Project were approved by the JCCB; and

WHEREAS, pursuant to notice duly posted as required by state law, the JCCB received bid proposals for the Project; and,

WHEREAS, each bid submitted for the Project received careful consideration, and it is necessary and advisable to award the contract for the Project.

BE IT THEREFORE RESOLVED by the JCCB as follows:

1. The bid for the Project submitted by the contractor, and in the amount set out below, is determined to be the lowest responsible bid received for the Project, and is fully responsive to the plans and specifications for the Project.

The JCCB hereby awards the contract for the Project to such contractor, and for the total estimated cost set out above, with final settlement on the basis of the unit prices set out in said contract, and on the actual final quantity of each class of material(s) furnished, and said award and resulting contract is subject to the Notice to Bidders, the plans and specifications for the Project, the terms of the bidder's written proposal, and the contractor's submittal of satisfactory bonds and insurance.
- 3. The JCCB hereby fixes the amount of the contractor's performance and/or payment bonds at 100 percent of the amount of the contract.
