Any applicant requesting a permit for a display of Class C consumer fireworks shall have an operator who is certified by a nationally-recognized fireworks safety organization such as the AFA or PGI.

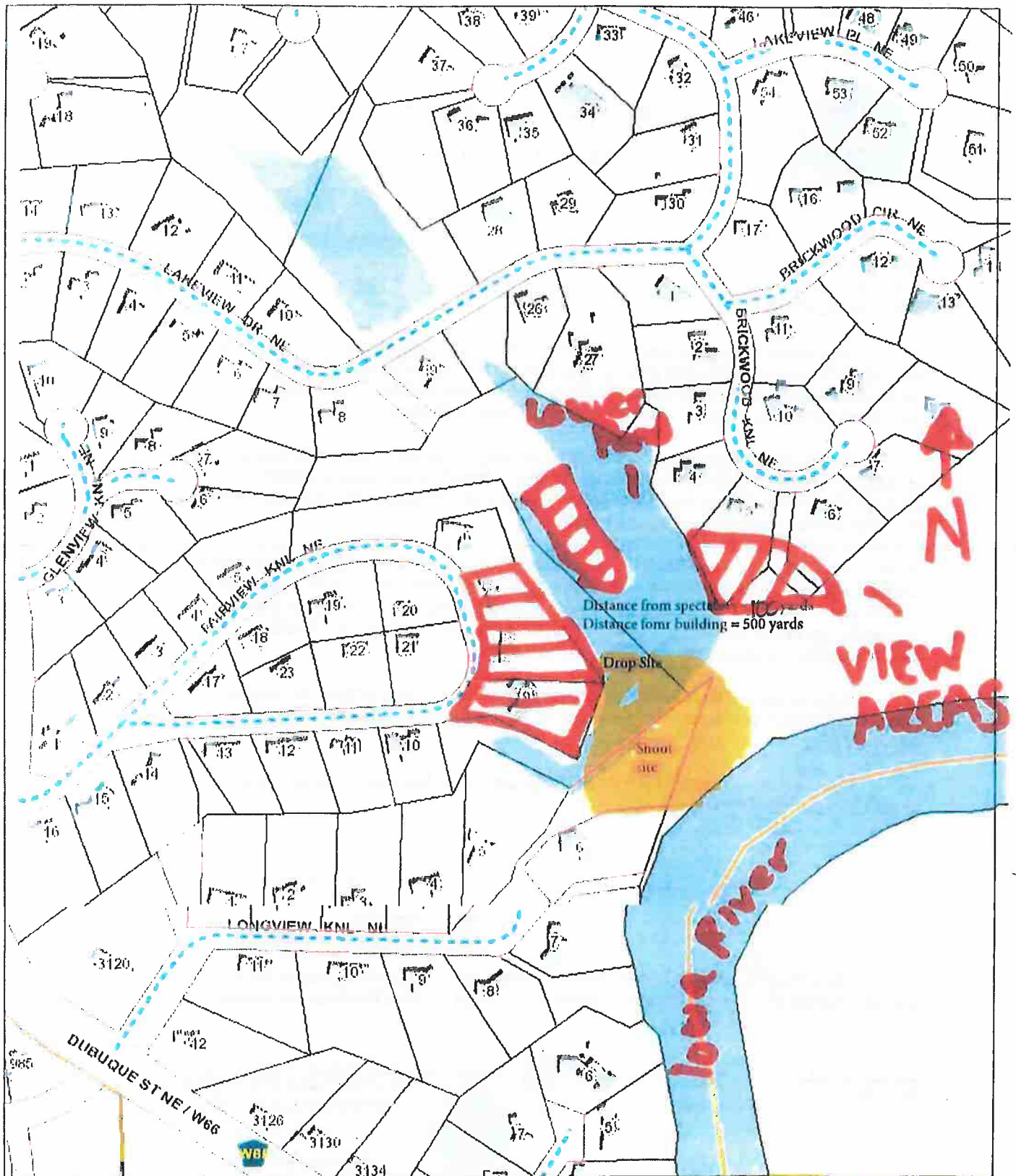

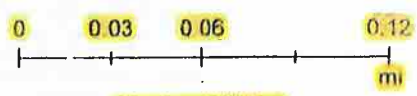
