JCCM Updates

Our accreditation is now due January 2024. We received a one-year extension.

Case Managers are currently working with their members and families to adjust services to meet their needs since the Public Health Emergency (PHE) has ended. During the PHE, the Centers for Medicare & Medicaid (CMS) allowed certain flexibilities. CMS allowed a 6-month extension for the majority of these flexibilities putting the actual end date as November 11, 2023. Iowa Medicaid has requested that the flexibility of allowing spouses, parents of minors, and family members to provide direct services become a waiver amendment, meaning it will be allowed from now on.

On April 7, 2023, CMS approved two “new” flexibilities that will replace respite while the caregiver was working which was allowed during the PHE. These two services are: Medical Day Care for Children and Adult Day Care (in the home).

Please help me get the word out regarding the HIPP (Health Insurance Premium Payment) Program. This is a win-win for members as their insurance premiums are reimbursed by Iowa Medicaid, they do not have to enter the managed care system, and they can have us provide Case Management 😊
