Whereas, Iowa Code section 459.304(3) sets out the procedure if a Board of Supervisors wishes to adopt a construction evaluation resolution relating to the construction of a confinement feeding operation structure; and

Whereas, only counties that have adopted a construction evaluation resolution can submit to the Department of Natural Resources (DNR) an adopted recommendation to approve or disapprove a construction permit application regarding a proposed confinement feeding operation structure; and

Whereas, only counties that have adopted a construction evaluation resolution and submitted an adopted recommendation may contest the DNR's decision regarding a specific application; and

Whereas, by adopting a construction evaluation resolution the Board of Supervisors agrees to evaluate every construction permit application for a proposed confinement feeding operation structure received by the Board of Supervisors between February 1, 2024 and January 31, 2025 and submit an adopted recommendation regarding that application to the DNR; and

Whereas, the Board of Supervisors must conduct an evaluation of every construction permit application using the master matrix created in Iowa Code Section 459.305, but the Board's recommendation to the DNR may be based on the final score on the master matrix or may be based on reasons other than the final score on the master matrix.

Now, therefore, be it resolved by the Board of Supervisors of Johnson County that the Board of Supervisors hereby adopts this construction evaluation resolution pursuant to Iowa Code Section 459.304(3).

RESOLUTION NO. 01-04-24-01

RESOLUTION ESTABLISHING A GREENHOUSE GAS REDUCTION GOAL FOR THE FLEET OF JOHNSON COUNTY LOCAL GOVERNMENT IN IOWA

WHEREAS, reducing energy use and greenhouse gas (GHG) emissions is imperative to reduce or slow climate change and pollution; and as stated in the recently issued Fifth National Climate Assessment, “future climate change impacts depend on choices made today”; and

WHEREAS, Johnson County previously adopted a resolution of commitment on June 8, 2017, to honor the Paris Climate Agreement goals, including the commitment to “increase our efforts to cut greenhouse gas emissions, support a clean energy economy, stand for health and environmental justice,” and the Johnson County 2018 Comprehensive Plan includes the goal of “Support and advance energy efficiency, resource conservation, and renewable energy programs, policies, and uses” and is currently being updated to further climate action goals; and

WHEREAS, the transportation sector is one of the largest contributors to area GHG emissions, representing 39% of countywide emissions in the most recent (2020) community GHG inventory and 35% of emissions in the most recent (2017) operational GHG inventory, and our operational inventory cites the importance of using “*less* energy and *cleaner* energy...to lead to fewer GHG emissions”; and

WHEREAS, communities in our region such as the City of Iowa City and the City of Cedar Rapids have adopted operational fleet electrification or cleaner fuel goals; and

WHEREAS, Johnson County, whose fleet is still largely dependent on fossil fuels, can further learn from those communities and others; and

WHEREAS, Johnson County will embark on a fleet study to investigate and plan for fleet electrification in pursuit of reducing greenhouse gases and serving as an additional example for the community by reducing fossil fuel dependence; and

WHEREAS, Johnson County has an additional and equally important vested interest in reducing GHG emissions to improve the air quality for Johnson County residents;

NOW, THEREFORE, BE IT RESOLVED by the Johnson County Board of Supervisors that the Board of Supervisors will set an operational fleet GHG emissions reduction target of at least 25% by 2045 from year 2020 levels.

RESOLUTION FOR CEASEFIRE IN THE PALESTINIAN WEST BANK, GAZA, THE STATE OF ISRAEL, AND THE MIDDLE EAST

WHEREAS, we, the Johnson County Board of Supervisors recognize, celebrate, and defend the human rights of every person; and

WHEREAS, the Johnson County Board of Supervisors acknowledges the events in Israel and the Palestinian Occupied Territories, now spilling into the greater Middle East, since 7 October 2023 as well as prior to that date; and

WHEREAS, disbursements of United States foreign aid, a portion of which is funded by Johnson County residents' taxes, are governed by domestic and international law; and

WHEREAS, an immediate ceasefire, return of those unlawfully detained and recommitment to a political, not martial, solution is the only durable and feasible path out of the present crisis.

THEREFORE BE IT RESOLVED BY THE BOARD OF SUPERVISORS THAT Johnson County calls for:

1. An immediate and permanent ceasefire in the Palestinian West Bank, Gaza, the State of Israel, and the Middle East, including but not limited to Hamas and Israel, and those regional militias and states that sponsor said militias; and
2. Express Congressional authorization of any military action in the region, including Babel-Mandeb (the Gate of Grief); and
3. Direct Congressional oversight of all military aid from the United States Government, especially the consistent application of humanitarian restrictions upon such aid; and,
4. The timely and safe return of all unlawfully detained by any party; and,
5. The immediate and unconditional provision of humanitarian aid to Palestinians in Gaza; and,
6. A multinational strategy for the rebuilding of Gaza and the safe return of all displaced Palestinians; and,
7. The protection of our First Amendment rights to protest, to criticize government, while affirming the criticism of the governments of Israel and Palestine is not inherently anti-Semitic or anti-Arab; and,
8. A commitment to fight antisemitism, Islamophobia, and bigotry toward Palestinians, Arabs, and Israelis in all forms.

**FY24 APPROPRIATION CHANGES TO SECONDARY ROADS (DEPT. 49) AND
AMERICAN RESCUE PLAN ACT (DEPT. 35)**

WHEREAS, the appropriations for the American Rescue Plan Act (ARPA) Department, are not sufficient to meet payments for impending expenditure obligations, and

WHEREAS, the Secondary Roads Department has available funds in its budget; and

WHEREAS, pursuant to section 331.434(6) of the Code of Iowa, a department appropriation may be decreased without a public hearing if the decrease is not more than the greater of \$5,000 or ten percent of the department's total budget; and

THEREFORE, BE IT RESOLVED by the Johnson County Board of Supervisors, that the American Rescue Plan Act (ARPA) (Dept. 35), Roads & Transportation Service Area, is herewith appropriated an additional \$50,000 and a total appropriation of \$50,000 for Fiscal Year 2023-2024. The appropriation for Secondary Roads (Dept. 49), Roads & Transportation Service Area, is decreased \$50,000 for a total appropriation of \$13,376,547 for fiscal year 2023-2024.
