

## Inspection Published Comment:

This onsite visit is a recheck in reference to a warning letter sent on 1/21/2026. The following items have been corrected:

- #10: No items are stored within handwashing sink.
- #15: All raw items properly stored in coolers throughout establishment.
- #22: Foods within cold holding are held at the correct temperatures.
- #41: Sanitizer was set up at time of inspection and tested at the correct PPM.
- #43: Scoops in use have dedicated handles and are stored with handles outside of contact with food.
- #47: All the food contact surfaces are durable and non-absorbent.
