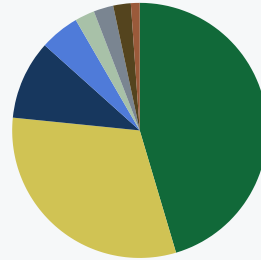

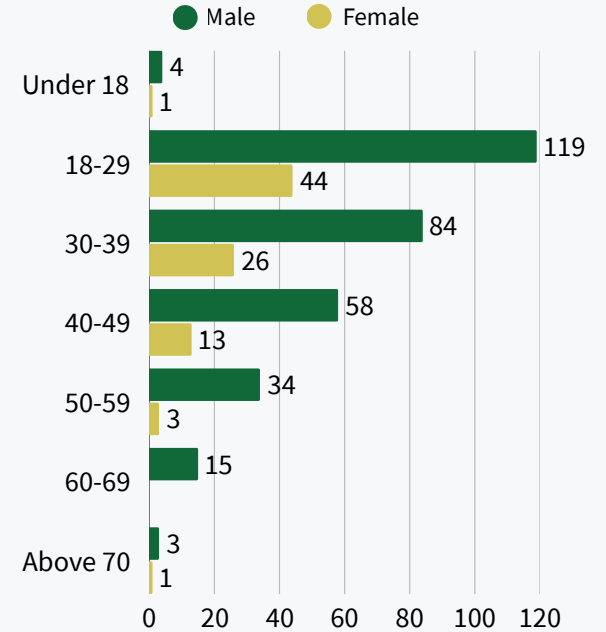

Population by Arresting Agency - April 2026

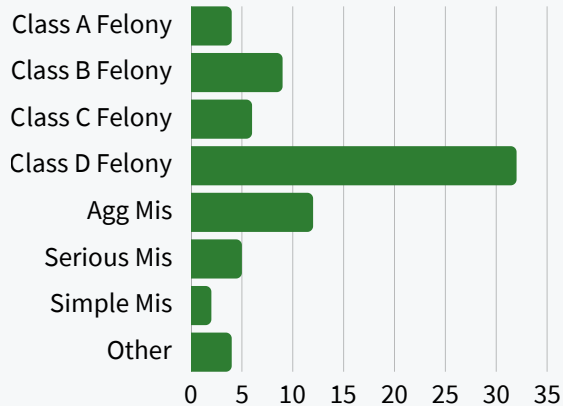

Bookings by Gender April 2026



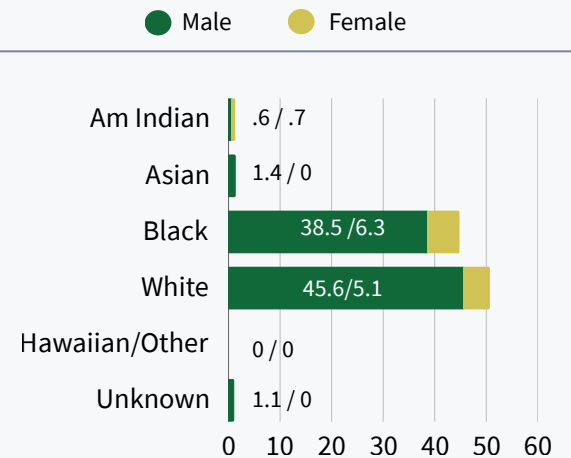

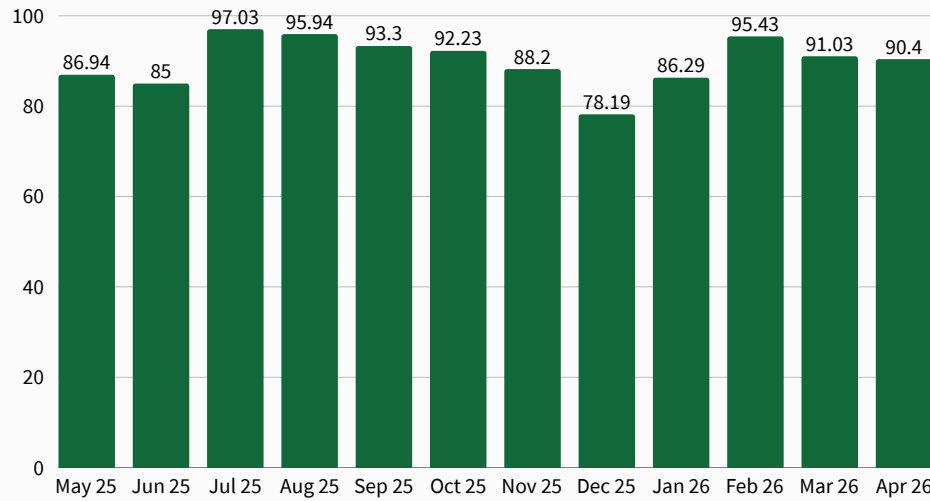




Average Daily Jail Population



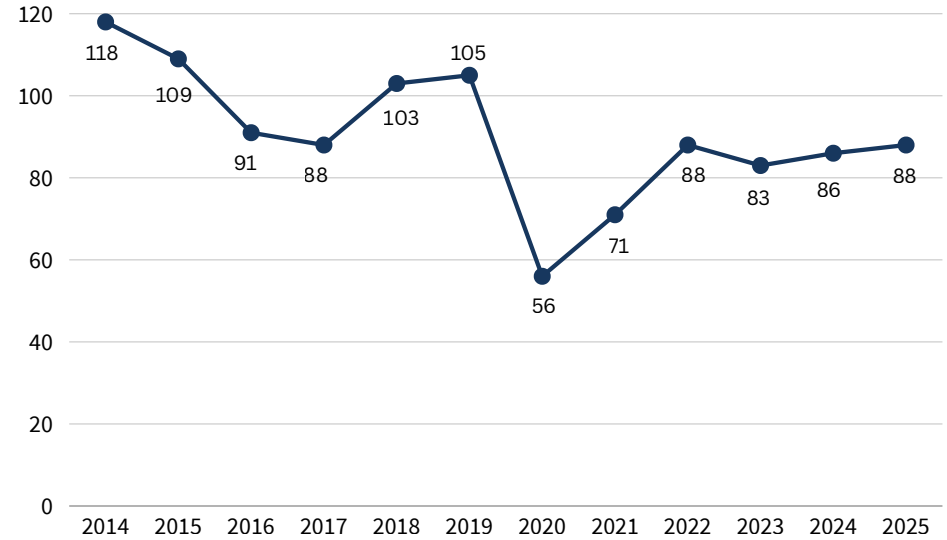
12 Month Trend



Average Daily Jail Population

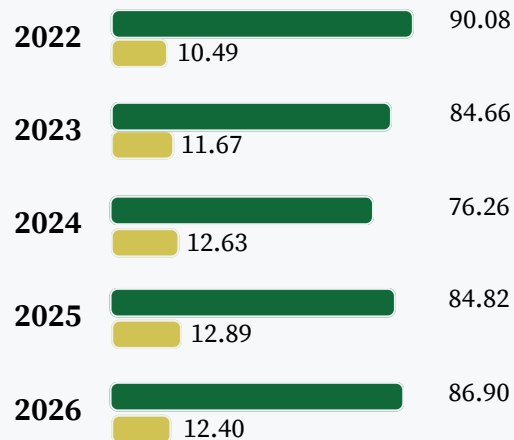


12 Year Trend

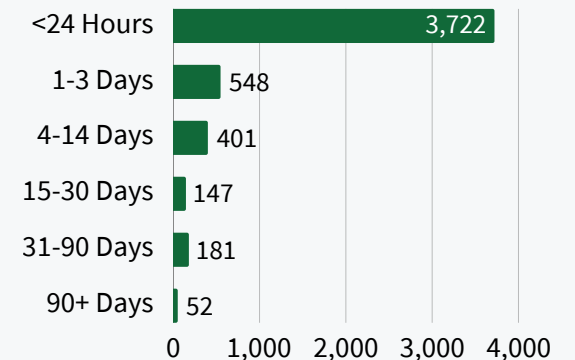

Over 73% of inmates released within 24 hours





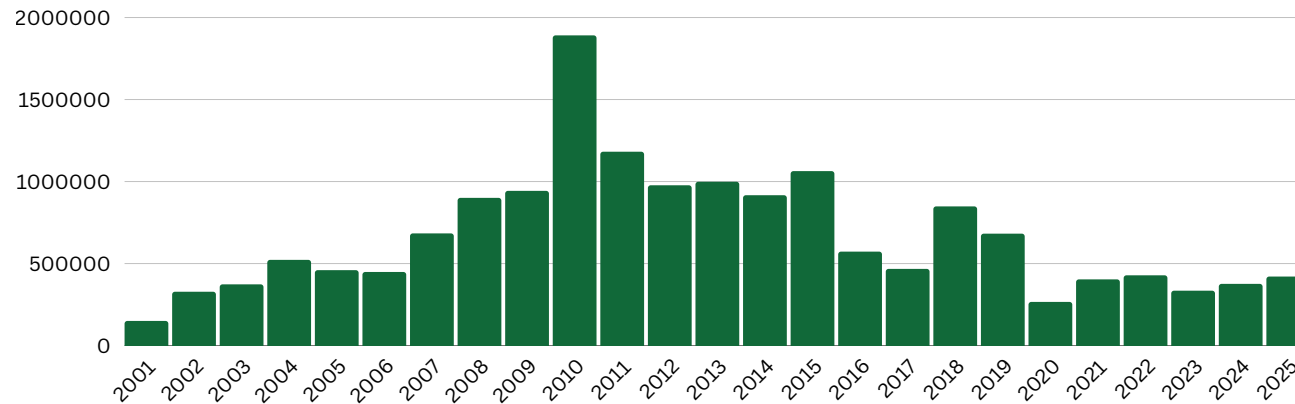
Out of County Inmate Housing and Transportation Costs
