Discussed proper storage of clean equipment and utensils. Management was advised that clean glasses and utensils must be stored on clean, non-absorbent, and easily cleanable surfaces to protect them from contamination. The person in charge acknowledged and agreed to discontinue the use of absorbent paper towels as a storage surface for clean utensils.
