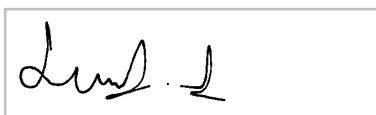
Routine inspection conducted. A Letter of Correction was issued for violation (#3). See letter for compliance details.
