A pre-opening inspection was conducted for a food establishment that has been operating without a valid food establishment license.

Scope of Business: The facility, located at 1041 Arthur St, Iowa City, IA 52240, serves as the main kitchen for the daycare located in the same building and as a central kitchen for food preparation and cooking. Per management, food is also prepared and transported to Neighborhood Centers of Johnson County, located at 2651 Roberts Rd, Iowa City, IA 52246, in insulated food transport containers for service.

The establishment is equipped to prepare, cook, hot hold, cold hold, and transport foods consistent with the current menu and operation.

Limitations: No limitations based on the current menu and the facility's capability and capacity.

The establishment has a Certified Food Protection Manager. The person in charge provided CFPM documentation to the inspector during the pre-opening inspection.

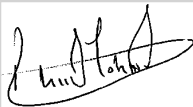
License approval is pending submission of the appropriate food establishment license application, completion of the application review process, and payment of the applicable licensing fee.
